My previous employer, TSB Bank, a residential consumer bank in NZ, agreed in July 2021 to pay NZ\$3.85m in civil penalties after acknowledging it failed to comply with NZ anti-money laundering legislation. This related to time periods prior to my employment and accordingly my role involved oversight of the uplift activities undertaken by TSB Bank after these failings were identified, and I worked closely with the regulator (Reserve Bank of New Zealand) as part of the bank's go-forward compliance.
